RESSEGAYRE BOOKING CONDITIONS

1. Bookings.

The booking form must be completed by the party leader, signed and returned to us by post, fax or email. On receipt of this, we will acknowledge it and hold your booking for seven days during which time you must pay a deposit of £150 into a designated bank account sent to you. When your deposit reaches our bank we will confirm your booking and this will act as our (the owner) contract with you (the client)

2. Final Payment.

Six weeks before your holiday date the balance of payment plus a £150 security deposit must be paid into our account. The security deposit is refundable to you 14 days after your departure if the Gîte and its contents are deemed to be in good order. Should your holiday date commence within six weeks of your booking then full payment and the security deposit must be paid at the time of booking.

3. Cancellation.

If you cancel your booking before the final payment is received then your deposit will be forfeited. If cancellation is after the final payment has been paid then all monies will be forfeited unless we can re-let the accommodation, in which case some or all of the monies will be refunded. It is essential that you take out holiday travel, health, accident and cancellation insurance at the time of booking.

If, through circumstances beyond our control, the accommodation is not available for the period booked then we will endeavour to find other accommodation to your satisfaction, or refund your monies in full.

4. Liabilities.

The booking contract is between you, the client, and us, the owner, and applies only to these parties. We reserve the right to terminate your rental without refund should you abuse the property, contents, pool or grounds. Any damage to the pool liner and subsequent loss of earnings will be charged in full over and above the security deposit. The information which we have supplied is believed to be accurate, but we cannot accept liability for any circumstance that may arise which is beyond our control.

4b. Force Majeure.

We will not be liable for any act which could be considered a Force Majeur. That is, any event which could not be predicted or avoided by us such as: nuclear disaster, war, or the threat of war, terrorist activity, riot or public disorder, civil strife or industrial dispute, government action, transport problems and unseasonable weather.

5. The Property.

The Gîte is normally available from Saturday to Saturday during High Season, but if this not convenient then please contact us as we may be able to oblige subject to availability. The accommodation will be available by 4pm on the day of arrival and must be vacated by 10am on the day of departure for preparation for the next guests.

The Gîte should be left in the same state of cleanliness as you found it and any damage or breakages should be notified to us. This and any excess cleaning required will be deducted from the security deposit. There is a no smoking rule in the Gîte. Linen, except swimming towels, is provided and changed weekly. Please only use the toilet rolls and cleaning equipment supplied as we have a septic tank waste system.

No pool equipment should be touched by clients and French law requires pool safety measures which should not be overruled, but states that parents/adults are primarily responsible for the safety of children and does not negate parental responsibility. The minimal house rules should be observed for your own safety. We are situated in a rural area so birds, animals and insects are accepted as an inherent part of rural life.

Completion of the booking form will constitute as acceptance of these conditions.
